Throughout my career, my research interests have been driven by clinical needs, with an over-arching focus on novel, interdisciplinary, and outcome-driven assessment and service-delivery models, along with professional and public advocacy and education.

Behavioral sleep medicine: service-delivery models; sleep, concussion, and athlete brain health (risk mitigation and prolonged post-concussive symptoms); education for families, teams, and related providers; incorporating sleep topics and screenings into primary care; sleep and athletes; telehealth models to enhance access to care; school-based and psychosocial supports for disorders of hypersomnolence; embedding sleep science into general clinical, school, and neuropsychological training; pediatric practice models incorporating structured parent behavior management training; community education and advocacy.
